BE IT RESOLVED, that the City Manager be and is hereby authorized to offer to purchase said Property.

BE IT FURTHER RESOLVED, that the City Comptroller be and is hereby authorized to expend an amount not to exceed \$160,000 from Open Space Park District Bond Fund 30252 as payment for said Property and related costs.

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized to

accept the deed to said Property without further Council action.
