BE IT FURTHER RESOLVED, that the Council hereby accepts on behalf of The City of -PAGE 1 OF 2-

San Diego any and all abutters' rights of access in and to Lot 1, adjacent and contiguous to 58th Street; in and to Lot 8, adjacent and contiguous to Bonita Drive; and in and to Lot 11 and 12, adjacent and contiguous to Olvera Avenue, all as shown on the MAP within this subdivision. The City Engineer is authorized to revest all or part of said access rights if there is a change in circumstances making access necessary and safe.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to endorse upon the MAP, as and for the act of the Council, that the Council has approved the MAP and that the streets are accepted on behalf of the public as stated in this resolution.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to transmit the MAP to the County Recorder of the County of San Diego, California, for recordation.
