A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE TRANSFER AND EXPENDITURE OF FUNDS PREVIOUSLY AUTHORIZED FOR THE NAVAL HOSPITAL EXCHANGE PARCEL TO BE USED FOR THE INSPIRATION POINT PRECISE PLAN.

WHEREAS, in the fall of 1996, the City accepted Phase One of the historic central courtyard on Inspiration Point, a funding balance of \$77,891 currently remains on the project; and

WHEREAS, subsequent to the acceptance of Phase One of the Inspiration Point Project, construction began on necessary improvements to the Balboa Park East Mesa Northeast Corner, the City authorized the location of the Balboa Park Activity Center, and the North Park community suggested sidewalk extension on the west side of Pershing Drive to address safety concerns; and

WHEREAS, additional funding is necessary to accomplish these projects, NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the City Auditor be and hereby is authorized to transfer and expend \$57,902 from CIP No. 21-828.0, NAVAL HOSPITAL EXCHANGE PARCEL LANDSCAPING AND RELATED WORK, San Diego Facility Equipment Leasing Corporation Fund (Fund No. 91106) to CIP No. 21-856.0, INSPIRATION POINT PRECISE PLAN.
- 2. That the City Auditor be and hereby is authorized to transfer and expend \$19,989 from CIP No. 21-828.0, NAVAL HOSPITAL EXCHANGE PARCEL LANDSCAPING AND

RELATED WORK, Navy Hospital Building Demolition Fund (Fund No. 60252) to CIP No. 21-839.0, BALBOA PARK EAST MESA NORTHEAST CORNER DEVELOPMENT.
