WHEREAS, the widening of Mission Gorge Road from four lanes to six lanes requires the acquisition of 468 square feet of a commercial lot; and

WHEREAS, the property owner donated the required right-of-way instead of accepting the City's offer of \$6,325 for the property rights required; and

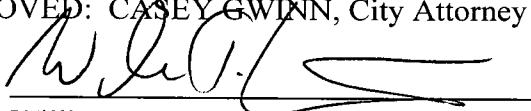
WHEREAS, it is necessary for the City to pay for title, escrow and miscellaneous costs which total \$1,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller be and is hereby authorized to expend \$1,000 from CIP No. 52-501.0, Mission Gorge Road Widening Trans Net Fund 30300, for the acquisition of property rights for this project and acceptance of the donated right-of-way.

BE IT FURTHER RESOLVED, that Council hereby accepts the "reservation for future street" referred to in Map No. 7554, approved by City Council Resolution No. R-207370, dated February 15, 1973, recorded February 21, 1973, as File No. 73-045509.
