ADOPTED ON SEP 23 1997

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH THE YMCA TO PROVIDE AFTER SCHOOL DAY CAMP PROGRAMS AS PART OF THE NEIGHBORHOOD PRIDE AND PROTECTION PROGRAM AND TO EXPEND THE AMOUNT OF \$242,000 FOR THAT PURPOSE.

WHEREAS, as part of their PRYDE Program, the YMCA operates youth after school day camp programs in seven high crime communities within the City of San Diego, designed to reach "at risk" youth with an anti-drug/gang education message, and wholesome recreation activities; and

WHEREAS, the PRYDE Program has been in effect since 1992 and has proven to be effective and successful with the youth that have participated in it; and

WHEREAS, the City wishes to extend the PRYDE Program to provide between 320 and 560 the opportunity to participate during Fiscal Year 1998; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and is hereby authorized and empowered to enter into an agreement with the YMCA OF SAN DIEGO COUNTY, INC., to provide youth after school day camp programs as part of the City's Neighborhood Pride and Protection Program for Fiscal Year 1998, a copy of which is on file in the office of the City Clerk as Document

No. RR- 289212

2. That the expenditure of an amount not to exceed Two Hundred Forty-Two Thousand Dollars (\$242,000) from Fund 18533, Dept. 4141, Org. 4112, is hereby authorized, solely and exclusively for the purpose of providing funds for the above agreement.
