Grant Award Agreement, including civil court actions for damages, shall be the responsibility of

The City of San Diego. The State of California and OCJP disclaim responsibility for any such

liability;

BE IT FURTHER RESOLVED, that grant funds and/or resources received hereunder

shall not be used to supplant expenditures controlled by this body;

BE IT FURTHER RESOLVED, that personnel positions funded hereunder are not

subject to local hiring freezes.
