


RESOLUTION NUMBER R- 289240 (R-98-284)

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized to execute a Reimbursement Agreement between The City of San Diego and Affinity Homeowners Association, a copy of which is on file in the office of the City Clerk as Document No. RR- 289240, for Reclaimed Water Retrofitting in the amount of \$126,000.00; and

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and is hereby authorized to expend not to exceed \$141,000 from Water Revenue Fund 41500, CIP No. 70-941.0, Annual Allocation for Reclaimed Water Retrofit Systems, of which \$126,000 is to fund the Reimbursement Agreement and \$15,000 is to fund required work by City Forces.
