


RESOLUTION NUMBER R- 289270 (R-98-320)

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized to execute a Reimbursement Agreement between The City of San Diego and Alexandria Real Estate Equities, Inc., a copy of which is on file in the office of the City Clerk as Document No. RR- 289270, for design and construction costs required to retrofit existing onsite potable water distribution system to accept reclaimed water for the purpose of irrigation for property located at 11099 N. Torrey Pines Road, San Diego, California, in the amount not to exceed \$74,124.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and is hereby authorized to expend \$89,124 from Water Revenue Fund 41500, CIP No. 70-941.0, Annual Allocation for Reclaimed Water Retrofit Systems, of which \$74,124 is to fund the Reimbursement Agreement and \$15,000 is to fund required work by City Forces.
