# RESOLUTION NUMBER 289277

# ADOPTED ON **QCT 0 7 1997**

A RESOLUTION DETERMINING AND DECLARING THAT THE PUBLIC INTEREST, CONVENIENCE AND NECESSITY OF THE CITY OF SAN DIEGO REQUIRE THE ACQUISITION OF FEE SIMPLE TITLE, SLOPE EASEMENTS AND TEMPORARY CONSTRUCTION EASEMENTS TO THE PROPERTY DESCRIBED HEREIN FOR THE CONSTRUCTION, IMPROVEMENT, OPERATION AND MAINTENANCE, AND INCIDENTS THERETO, OF THE 43<sup>RD</sup> AND NATIONAL STREET REALIGNMENT PROJECT; THAT THE PROPERTY IS LOCATED ALONG 43<sup>RD</sup> STREET, NATIONAL AVENUE AND LOGAN AVENUE, IN THE SOUTHCREST COMMUNITY, WITHIN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA; THAT THE PROJECT IS PLANNED OR LOCATED IN THE MANNER THAT WILL BE MOST COMPATIBLE WITH THE GREATEST PUBLIC GOOD AND THE LEAST PRIVATE INJURY; THAT THE PROPERTY SOUGHT TO BE ACQUIRED IS NECESSARY FOR THE PROJECT; THAT ACQUISITION BY EMINENT DOMAIN IS AUTHORIZED BY LAW; AND DECLARING THAT THE OFFER TO PURCHASE THE PROPERTY REQUIRED BY GOVERNMENT CODE SECTION 7267.2 HAS BEEN MADE TO THE OWNERS OF RECORD; AND DECLARING THE INTENTION OF THE CITY OF SAN DIEGO TO ACQUIRE THE PROPERTY UNDER EMINENT DOMAIN PROCEEDINGS; AND DIRECTING THE CITY ATTORNEY OF THE CITY OF SAN DIEGO TO COMMENCE AN EMINENT DOMAIN ACTION IN THE SUPERIOR COURT OF THE STATE OF CALIFORNIA, IN THE COUNTY OF SAN DIEGO, TO CONDEMN, ACQUIRE AND OBTAIN IMMEDIATE POSSESSION OF THE PROPERTY FOR THE USE OF THE CITY.

WHEREAS, the Council of The City of San Diego ("City") has provided notice to those persons designated in Code of Civil Procedure Section 1245.235, and has provided them a reasonable opportunity to appear and be heard on the matters referred to in Code of Civil

Procedure Section 1240.030; NOW, THEREFORE,

BE IT RESOLVED, THAT THE COUNCIL OF THE CITY OF SAN DIEGO HAS FOUND AND DETERMINED EACH OF THE FOLLOWING:

Section 1. That the proposed 43<sup>rd</sup> and National Realignment Project will upgrade the existing street system by realigning the three existing "T" intersections located at National Avenue/South 43<sup>rd</sup> Street, Logan Avenue/South 43<sup>rd</sup> Street and Logan Avenue/San Pasqual Street, to create one unified, signalized intersection. The proposed plan will enable the City to realign these streets for a smooth continuous traffic flow, while acquiring the minimum amount of property needed. The resultant project will provide a safer, more efficient street system for the community.

The project is required to accommodate current and projected traffic flow in the Southcrest Redevelopment Project Area, and is consistent with the Southcrest San Diego Community Plan. The General Plan classifies National Avenue as an east/west prime arterial and that carries over 12,000 vehicles a day. Forty-third Street is the major north/south arterial. It is anticipated that these streets will carry significantly more traffic with the redevelopment of the State Route 252 Corridor. The project is a major component in the development of the State Route 252 Corridor, and will make necessary traffic enhancements to handle the increased daily trips associated with the residential, industrial and commercial development of the corridor.

Section 2. That the public interest, convenience and necessity of the City, and the inhabitants thereof, require the acquisition of fee simple title and easements to the property described hereafter for the 43<sup>rd</sup> and National Realignment Project, a public street or streets, and incidents and appurtenances thereto; that the property is to be used for the realignment of three intersections in the Southcrest community; that the project includes construction, improvement,

operation and maintenance; that the interests to be acquired include fee simple title and easements for slope and temporary construction purposes; and that the property is located in the City of San Diego, County of San Diego, State of California, as more particularly described hereafter.

Section 3. That the 43<sup>rd</sup> and National Realignment Project is planned or located in the manner that will be most compatible with the greatest public good and the least private injury.

Section 4. That the fee simple title and easements sought to be acquired are necessary for the 43<sup>rd</sup> and National Realignment Project, for municipal purposes.

Section 5. That the acquisitions sought herein are for a public use authorized by the following code sections: Charter of The City of San Diego Section 220; Code of Civil Procedure Sections 1240.010, 1240.110, 1240.120, 1240.150, 1240.320, 1240.410, 1240.430 and 1255.410; The Improvement Act of 1911; Streets and Highways Code Sections 5100, 5101, 5102, 5023 and 5023.1; and Government Code Sections 37350.5 and 40404.
