RR- 289289-2, granting to said City a portion of Parcels 2 and 3 of Parcel Map No. 1318 in Kearny Mesa for the development of permanent access into the adjacent City-owned parcel, Assessor Parcel Numbers 356-031-07 and 13, as more particularly described in said deed.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and is hereby authorized to expend an amount not to exceed \$40,000 from Fund No. 41201, CIP 37-251.3 (South Miramar Gas Collection System) for acquisition of property rights and related acquisition costs.
