## RESOLUTION NUMBER R- 289315 ADOPTED ON OCT 21 1997

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE CITY MANAGER TO EXECUTE A SECOND AMENDMENT TO AGREEMENT WITH BERMUDES ARCHITECTS FOR ADDITIONAL PROFESSIONAL SERVICES NECESSITATED BY UNFORSEEN CONDITIONS AND REQUIREMENTS OF THE PACIFIC BEACH RECREATION CENTER ADDITION PROJECT.

WHEREAS, on April 14, 1993, The City of San Diego ("City") entered into a professional services agreement with Burmudes Architects ("Consultant") for the development of the Pacific Beach Recreation Center Addition, a copy of the Agreement is on file in the Office of the City Clerk as Document No. C-04701; and

WHEREAS, on July 21, 1994, City executed the First Amendment to Agreement with Consultant to provide additional professional services necessary to accommodate disabled access, lighting and miscellaneous code changes which occurred while the project had been awaiting funding, a copy of the First Amendment to Agreement is on file in the Office of the City Clerk as Document No. C-05552; and

WHEREAS, a Second Amendment to Agreement is now needed to provide for the unexpected requirement by the City's Development Services Business Center that an existing sewer mainline be relocated, and to provide for other changes to the project not previously anticipated; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager, or representative, is authorized to execute the Second

Amendment to Agreement with Bermudes Architects for professional services required for the Pacific Beach Recreation Center Addition, a copy of the Second Amendment to Agreement is on file in the Office of the City Clerk as Document No. RR-289315

- 2. That the City Auditor and Comptroller is authorized to transfer Seventy-Two Thousand Eight Hundred Seventy Dollars (\$72,870) from CIP No. 29-420.0, Pacific Beach Community Park Requirements, Phase II, Pacific Beach Urban Community Fund, Fund No. 79507, to CIP No. 29-765.0, Pacific Beach Community Park Requirements, Phase I.
- 3. That the City Auditor and Comptroller is authorized to expend an amount not to exceed Two Hundred Thirty Thousand Eight Hundred Seventy Dollars (\$230,870) as follows: \$102,870 from CIP No. 29-765.0, Pacific Beach Community Park Requirements, Phase I, Pacific Beach Urban Community Fund, Fund No. 79507; and \$128,000 from CIP 44-001.0, MWWD Sewer Fund, Fund No. 41506, for the purpose of funding the above Second Amendment to Agreement with Bermudes Architects, and for additional costs anticipated for the previously approved construction contract and related costs.
- 4. That the Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
