


RESOLUTION NUMBER R- 289333 (R-98-431)

ADOPTED ON OCT 28 1997

WHEREAS, construction of a bridge across Smugglers Gulch on land owned by Shizue Yamamoto and the County of San Diego was completed under a right-of-entry permit with the understanding that The City of San Diego, at a later date, would acquire a permanent easement for the bridge from Shizue Yamamoto in favor of the County; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller be and is hereby authorized to expend an amount not to exceed \$15,000 from Fund No. 41509, CIP 40-910.1 (South Bay Ocean Outfall) for the purchase and related costs of a General Access Easement from Shizue Yamamoto to be conveyed directly to the County of San Diego as a part of the South Bay Ocean Outfall Project.
