A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE ACCEPTANCE OF GRANT FUNDS FROM THE STATE OF CALIFORNIA DEPARTMENT OF PARKS AND RECREATION TO BE USED FOR THE SAN YSIDRO/LARSEN ATHLETIC FIELD LIGHTS, AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE ALL NECESSARY DOCUMENTS IN CONNECTION WITH THE GRANT.

WHEREAS, on August 27, 1997, The City of San Diego was notified that they had been allocated \$73,875 in grant funds by the State of California Special Appropriations Account, to be used for the San Ysidro/Lane Field Lights Project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the City Manager, or representative, is authorized to accept and expend the grant funds.
- 2. That the City Manager, or representative, is authorized to conduct all negotiations, execute and submit all documents (including, but not limited to applications, agreements, amendments and payment requests) which may be necessary for the completion of the San Ysidro/Larsen Field Lights.
- 3. That there are or will be sufficient funds to operate and maintain the San Ysidro/Larsen Field Lights project.
- 4. That the City Auditor and Comptroller is directed to establish an interest bearing account for the grant funds.

- 5. That the addition of CIP No. 29-461.0, San Ysidro/Larsen Field Lights, is added to the Fiscal Year 1998 Capital Improvements Program.
- 6. That the transfer of grant funds into CIP No. 29-461.0, San Ysidro/Larsen Fields Lights, is authorized.
