WHEREAS, Shelter Island Sewer Improvements Project was awarded to HPS Plumbing Services, Inc. ("HPS"), on February 29, 1996; and

WHEREAS, during construction, three water main breaks occurred in an adjacent, existing 12-inch AC water main; and

WHEREAS, as a result of these three water main breaks, Shelter Island experienced water outages jeopardizing local fire protection and depriving numerous hotels and restaurants of their water supply; and

WHEREAS, the water main requires immediate replacement; and
WHEREAS, HPS is excavating the street at the location of the broken water main, and
WHEREAS, Change Order No. 5, dated May 20, 1997, was approved by Resolution No.
R-288949, adopted on July 14, 1997, NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$126,719.19 from CIP 73-330.0, Mission Valley Aquaculture Facility Demolition to CIP 73-851.1, Emergency Repair of 12-inch Water Main in Shelter Island Drive.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$126,719.19 from Water Revenue Fund 41500, 73-851.1, is hereby authorized, solely and exclusively for the purpose of providing funds for the construction of the emergency repair of 12-inch water main in Shelter Island Drive to supplement Resolution No. R-288949, provided

that the City Auditor first furnishes one or more certificates demonstrating that the funds necessary for such expenditure under established contract funding are on deposit in the City Treasury.

BE IT FURTHER RESOLVED, that the City Auditor, upon advice from the administering department, is hereby authorized to transfer excess budgeted funds, if any, to the appropriate reserve.

BE IT FURTHER RESOLVED, that City forces are hereby authorized to perform additional operational checks for a cost not to exceed \$5,457.29 from Water Revenue Fund 41500.
