BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to enter into negotiations and to execute change orders in connection with the following subsystems of the Reclaimed Water Distribution System:

- 1. Change Order No. 6, issued in connection with the contract between the City of San Diego and Ortiz Construction Company for the Genessee Avenue Subsystem, said contract having been filed in the office of the City Clerk as Document Number RR-287111, amounting to a net increase in the contract price of \$275,000.
- 2. Change Order No. 24, issued in connection with the contract between The City of San Diego and Albert W. Davies, Inc. for the Miramar Road Subsystem Extension (Reclaimed Water Package "B"), said contract having been filed in the office of the City Clerk as Document Number RR-286947, amounting to a net increase in the contract price of \$1,026,220.
- 3. Change Order No. 16, issued in connection with the contract between The City of San Diego and Schlumberger Industries for the Scripps Ranch Boulevard/I-15 Subsystem, said contract having been filed in the office of the City Clerk as Document Number RR-287197, amounting to a net increase in the contract price of \$276,409.
- 4. Change Order No. 8, issued in connection with the contract between The City of San Diego and Vadnais Corporation for the Miramar Road Subsystem/Miramar Road Subsystem Extension, Part 1, said contract having been filed in the office of the City Clerk as Document Number RR-286604, amounting to a net increase in the contract price of \$495,000.

5. Change Order No. 16, issued in connection with the contract between The City of San Diego and Thomas Pipeline for the University City Subsystem, said contract having been filed in the office of the City Clerk as Document Number RR-287056, amounting to a net increase in the contract price of \$700,427.
