BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and is hereby authorized to expend \$84,900 from Water Revenue Fund 41500, CIP No. 70-941.0, Annual Allocation for Reclaimed Water Retrofit Systems of which \$69,900 is to fund the Reimbursement Agreement and \$15,000 is to fund the required work by City forces.
