WHEREAS, the City Council made the general recommendation that the City manager establish a new fund to provide financial assistance to the Teen Center only if it should be necessary; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager be and is hereby authorized to establish the Mira Mesa Teen Center Special Fund 10516.1.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and is hereby authorized to transfer \$500,000 from 10516, Mira Mesa Community Fund to the Mira Mesa Teen Center Special Fund 10516.1

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and is hereby authorized to disburse interest only from the Mira Mesa Teen Center Special Fund 10516.1 at the direction and sole discretion of the City Manager, based upon requests for such funds submitted no more than once per lease year by the operator of the San Diego Regional Teen Center showing operating need.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and is hereby authorized to disburse interest and principal from the Mira Mesa Teen Center Special Fund

10516.1 to other capital improvement projects within the Mira Mesa area, as authorized and directed by City Council.
