for the public purpose for which they were granted and are not shown within this MAP because

they are abandoned pursuant to Section 66499.20 ½ of the State Subdivision Map Act.

BE IT FURTHER RESOLVED, that the City Council hereby certifies The City of San

Diego is the owner of Parcel 1 of the Map and consents to the preparation and recordation of this

MAP as described in this resolution.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to

endorse upon the MAP, as and for the act of the Council, that the Council has approved the MAP

and that the street is accepted on behalf of the public as stated in this resolution.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to transmit the

MAP to the Clerk of the Board of Supervisors of the County of San Diego, California.
