AN ORDINANCE AUTHORIZING EXTENSION OF WASTE MANAGEMENT OF SAN DIEGO CURBSIDE RECYCLING CONTRACT FROM MARCH 1, 1998 TO FEBRUARY 28, 1999.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an extension of the Agreement with Waste Management of San Diego, for collection of curbside recyclables, for the period of March 1, 1998 to February 28, 1999, under the terms and conditions set forth in Fourth Amendment to Agreement No. RR-276355, a copy of which is on file in the office of the City Clerk as Document No. 00- 18466

Section 2. That the City Manager and Auditor and Comptroller is hereby authorized to expend funds currently appropriated for this purpose, as set forth in the agreement between The City of San Diego and Waste Management of San Diego, Inc., and previously authorized by Resolution No. R-279826.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
