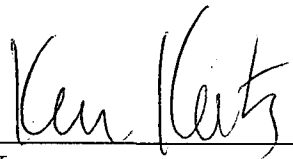
AN ORDINANCE AMENDING ORDINANCE NO. O-18424 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1997-98" BY ADDING NEW CIP PROJECT, CIP NO. 52-658.0, PESCADERO AVENUE BEACH ACCESS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-18424 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1997-1998," be and the same is hereby amended by adding new CIP Project, CIP No. 52-658.0, "Pescadero Avenue Beach Access."

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
