AN ORDINANCE AMENDING ORDINANCE NO. O-18424 (N.S.), THE FISCAL YEAR 1997-98 APPROPRIATIONS ORDINANCE, AND AUTHORIZING THE CITY MANAGER TO ENTER INTO THE NECESSARY AGREEMENTS TO IMPLEMENT THE 1994 MEMORANDUM OF UNDERSTANDING WITH THE COUNTY OF SAN DIEGO CONCERNING THE NEW DOWNTOWN JAIL FACILITY.

WHEREAS, it is necessary to amend the annual appropriations ordinance for fiscal year 1997-98, Ordinance No. O-18424 (N.S.), to provide for payments of approximately \$5.2 million and \$187,500 to the County of San Diego to implement the 1994 Memorandum of Understanding between the City of San Diego and the County of San Diego concerning the new downtown jail facility [1994 MOU], on file in the Office of the City Clerk as Document No. OO-18052; and

WHEREAS, the payments to the County are in anticipation of receiving \$6.0 million from the Corrections Corporation of America [CCA], through the County, for the early transfer of operational control of the East Mesa Detention Facility to CCA; and

WHEREAS, it is also necessary to authorize the City Manager to enter into the necessary agreements to implement the 1994 MOU; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That Ordinance No. O-18424 (N.S.) is hereby amended to appropriate the sum of \$5,222,553 from Fund No. 10355 for the purpose of participating with the County of San

Diego in the maintenance and operation of the County's new downtown jail facility, as set forth in the 1994 MOU.

Section 2. That Ordinance No. O-18424 (N.S.) is hereby amended to appropriate the sum of \$187,500 from Fund No. 10355 for the purpose of providing funds to modify the Las Colinas Jail Facility to receive City female misdemeanant arrestees, as set forth in the 1994 MOU.

Section 3. That the City Auditor and Comptroller is hereby authorized and directed to pay to the County of San Diego the sums of \$5,222,553 and \$187,500 for the purposes set forth above.

Section 4. That the City Manager is hereby authorized to enter into the necessary agreements to implement the terms and conditions of the 1994 MOU.

Section 5. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings as set forth in City Charter sections 16, 17, and 71.
