AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AMENDING ORDINANCE NO. O-18374 (NEW SERIES), ADOPTED JANUARY 13, 1997, TITLED "AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO ESTABLISHING THE LITTLE ITALY BUSINESS IMPROVEMENT DISTRICT PURSUANT TO THE PARKING AND BUSINESS IMPROVEMENT AREA LAW OF 1989 AND LEVYING AN ASSESSMENT AND CHARGE THEREIN FOR UPGRADING AND PROMOTING THE AREA."

WHEREAS, the Council of The City of San Diego approved the formation of the Little Italy Business Improvement District [District] by Ordinance No. O-18374 (New Series) on January 13, 1997; and

WHEREAS, the Council now desires to amend Ordinance No. O-18374 (New Series);  
NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

**Section 1.** That Section 1 of Ordinance No. O-18374 (New Series), adopted January 13, 1997, is hereby amended to read as follows:

Section 1. Pursuant to the Law, a parking and business improvement area is hereby established, to be known as the "Little Italy Business Improvement District," herein called "District." The area to be included in the District includes the Little Italy business community area within the following address ranges:

7. Exclusions: Those businesses that are exempt from assessments.

These include: independent beauticians renting a booth, home based businesses, and odd numbered addresses in range 1300 - 1700 of Front Street.

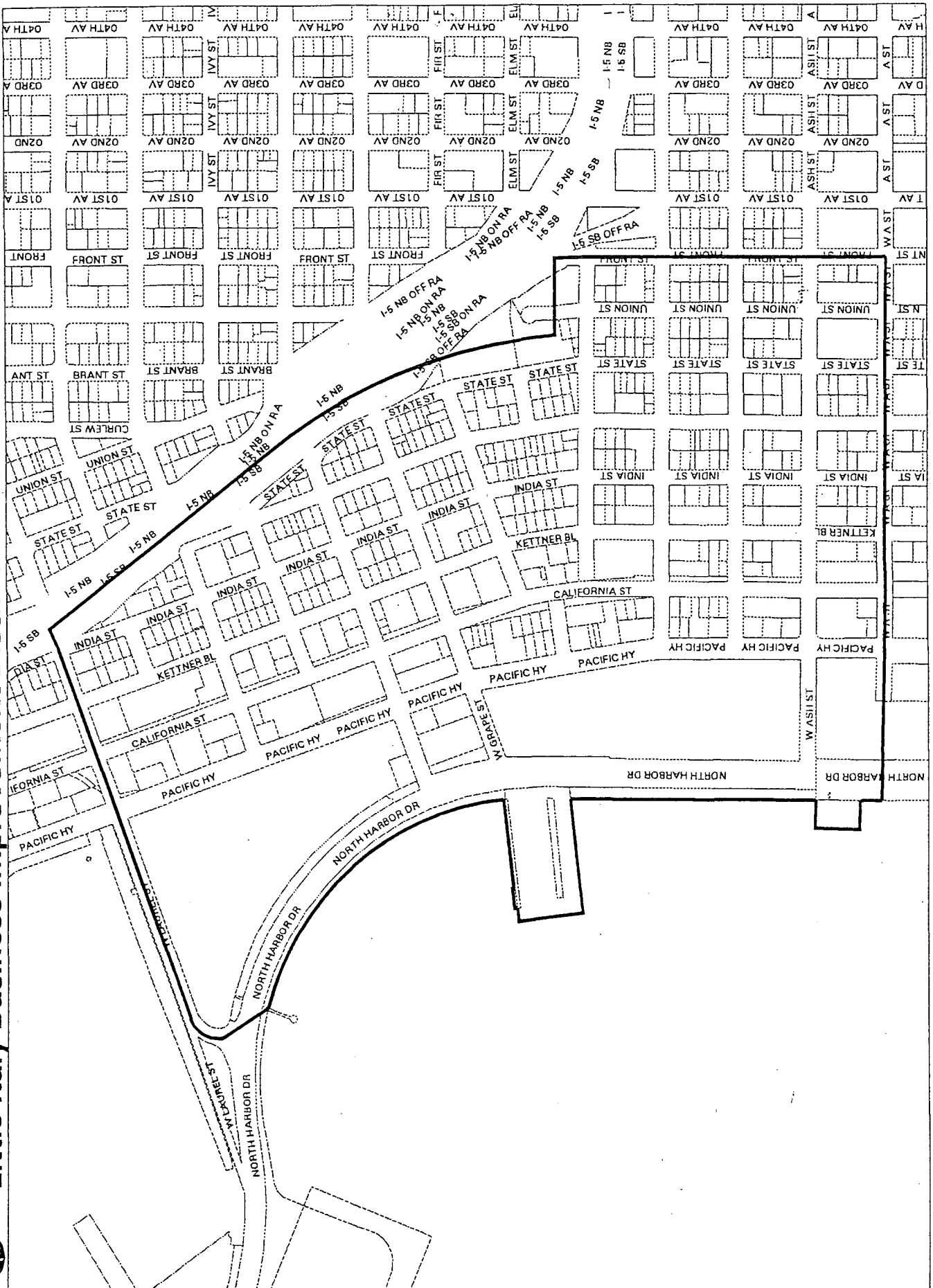
**Section 3.** That this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
