A RESOLUTION DESIGNATING FEBRUARY 20, 1998 AS THE DATE ON WHICH ALL PROPERTY IN THE SUNSET CLIFFS BOULEVARD (NEWPORT AVENUE TO BRIGHTON AVENUE) UNDERGROUND UTILITY DISTRICT MUST BE READY TO RECEIVE UNDERGROUND SERVICE AND MAY 22, 1998 AS THE DATE FOR REMOVAL OF ALL OVERHEAD UTILITY FACILITIES WITHIN THE SUBJECT DISTRICT.

WHEREAS, the Council by Resolution No. R-280724, adopted on September 29, 1992 and by Resolution No. R-281160, adopted on November 24, 1992, established the Sunset Cliffs Boulevard (Newport Avenue to Brighton Avenue) Underground Utility District, which required the conversion of certain overhead electric, communication, and community antenna television facilities; and

WHEREAS, pursuant to said resolutions, the date on which property in the district had to be ready to receive underground service and the date on which the removal of all poles, overhead wires, and associated overhead structures had to be effected was to be subsequently designated by resolution; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That February 20, 1998 is hereby established and designated as the date on which all property within the Sunset Cliffs Boulevard (Newport Avenue to Brighton Avenue) Underground Utility District must be ready to receive underground utility service, and that May 22, 1998 is hereby designated as the date on which all overhead utility facilities within the district must be removed.

- 3. That the City Manager is hereby directed to give notice to such affected persons and affected utilities in accordance with section 61.0511(b) of the San Diego Municipal Code.

BE IT FURTHER RESOLVED, as follows:

- That the City Auditor and Comptroller is authorized to establish Fund No. 78097 for the purpose of depositing Public Utilities Commission Case 8209 Utility Underground Allocation Funds.
- 2. That the City Treasurer is authorized to receive these funds from San Diego Gas & Electric Company.
- 3. That reimbursement payment to all qualified property owners in the subject Sunset Cliffs Boulevard Underground Utility District is hereby authorized as reimbursement for the electrical service underground conversion work done on private property, to be reimbursed from Case 8209 Funds deposited by San Diego Gas & Electric with the City Treasurer for this purpose.



4. That the City Treasurer is authorized to return to SDG&E undisbursed funds, if any, on written notice from SDG&E to the City that all electrical service conversions within the subject Sunset Cliffs Boulevard Underground Utility District have been completed.

BE IT FURTHER RESOLVED, as follows:

1. That the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$13,618 from CIP 37-028.0, Annual Allocation - Undergrounding of City Utilities, to Sublet CIP 37-294.2.

6. That the expenditure of an amount not to exceed \$13,618 from TransNet Fund No. 30300, Sublet CIP 37-294.2, is authorized, solely and exclusively to replace existing street lights in the subject Sunset Cliffs Boulevard (Newport Avenue to Brighton Avenue) Underground Utility District.
