- 3. NIXON-EGLI EQUIPMENT CO. (Santa Fe Springs, CA), Item 7 at a cost of \$122,673.38 including tax, terms Net 30 days;
- 4. CLAIREMONT EQUIPMENT CO. (San Diego, CA), Items 8, 9, 10 and 11 at a cost of \$351,303.79 including tax, terms Net 30 days; and
- 5. HAWTHORNE MACHINERY CO. (San Diego, CA), Item 12 at a cost of \$151,252.99 including tax, terms Net 30 days,

are hereby accepted and the City Manager is hereby authorized to execute contracts for furnishing PURCHASE AND LEASE/PURCHASE OF HEAVY DUTY MOTIVE EQUIPMENT, as may be required for a period of one (1) year beginning November 1, 1997 through October 31, 1998; with options to renew the contract for four (4) additional one (1) year periods, with price escalations not to exceed 10% of prices in effect at the end of each prior contract year.
