WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of public service easements by City Council resolution where the easements are no longer required; and

WHEREAS, the Encanto and Valencia Park Trunk Sewer Projects have replaced the existing trunk sewer and are now operational; and

WHEREAS, the easements for the existing sewer are no longer in use and should be vacated; and

WHEREAS, the City Council finds that:

- (a) the subject sewer easements have been superseded by relocation and there are no other public facilities located with the easements;
- (b) there is no present or prospective use of the sewer easements either for the sewer system for which the easements were originally acquired, or for other public use of like nature that can be anticipated;
 - (c) the public will benefit from the vacation through improved utilization of land;
- (d) the vacation is not inconsistent with the General Plan or an approved Community Plan; and
- (e) the sewer system for which the easements was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:
