BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 2. That the City Manager is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the above work, in accordance with the plans and specifications referred to above.
- 3. That the City Manager is further authorized to execute a contract with the lowest responsible bidder for the project, provided that the City Auditor and Comptroller first furnishes a certificate demonstrating that the funds necessary for expenditure under the contract are, or will be, on deposit in the City treasury.
- 4. That the City Auditor and Comptroller is hereby authorized to transfer \$380,000 from Fund No. 41509, CIP 45-910.3, Program Planning and Studies, to Metro Fund No. 41508, CIP 40-922.0, Metropolitan Operations Center Expansion.
- 5. That the expenditure of an amount not to exceed \$2,153,981 is hereby authorized, as follows: \$2,093,406 from Metro Fund No. 41508, CIP 40-922.0, Metropolitan Operations Center Expansion, solely and exclusively to provide funds for project construction and related costs; and \$60,575 from Metro Fund No. 41508, CIP 46-501.0, Annual Allocation Pooled Contingency,

solely and exclusively to provide funds for project contingency, provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds necessary for expenditure are, or will be, on deposit in the City treasury.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves on advice of the administering department.
