# RESOLUTION NUMBER R- 289734 ADOPTED ON FEB 1 7 1998

WHEREAS, the Scripps Ranch Reservoir is an essential facility necessary to provide an uninterrupted water supply to the citizens of San Diego; and

WHEREAS, rehabilitation of the reservoir is necessary to ensure maximum long term service. To perform the rehabilitation, the reservoir must be taken out of service. However, the Scripps Ranch Reservoir must be intact to meet peak domestic and fire season water demands during summer months, April through September, to protect the health and safety of the citizenry; and

WHEREAS, West Coast Painting and Blasting, Inc., was hired after competitive bidding to complete rehabilitation to the Scripps Ranch Reservoir; and

WHEREAS, West Coast Painting and Blasting, Inc. has failed to perform work as required by the contract documents, including the handling and disposal of hazardous material; and

WHEREAS, West Coast Painting and Blasting's failure to adequately handle and dispose of hazardous materials subjected the citizens of the City of San Diego to potential health and safety hazards; and

WHEREAS, for the reservoir to be in service in time to meet peak summer demands, rehabilitation work must begin immediately; and

WHEREAS, due to the above, the public interest and necessity demands the immediate expenditure of monies to safeguard the life, health and property of the citizenry; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council ratifies the City Manager's decision that West Coast Painting and Blasting, Inc. is in default of its contract for Scripps Ranch Reservoir Rehabilitation.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an emergency contract with Robinson Prezioso, Inc., in the amount of \$124,000, for lead paint clean-up/disposal at the Scripps Ranch Reservoir site, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 289734-1.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an emergency amendment to the contract with Robinson, Prezioso, Inc., for lead paint clean-up/disposal at the Scripps Ranch Reservoir site in the amount of \$10,200, under the terms and conditions set forth in the Purchase Order attached to the Agreement on file in the office of the City Clerk as Document

No. RR- 289734-2

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an emergency contract with Weststar, Inc., for the remaining work at the Scripps Ranch Reservoir site, in the amount of \$558,161, under the terms and conditions set forth in the Amendment on file in the office of the City Clerk as Document No. RR- 289734-3.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$400,000 from the Water Fund Unallocated Reserve (Fund 41500, program element 76226) to CIP 73-277.0.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$803,361 from Water Fund 41500, CIP 73-277.0, is hereby authorized, solely and exclusively for the purpose of executing these contracts and related expenses for completing the work on the Scripps Ranch Reservoir Rehabilitation Project.
