


RESOLUTION NUMBER R- 289791

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is authorized to execute a Reimbursement Agreement between The City of San Diego and San Diego Community College District, a copy of which is on file in the office of the City Clerk as Document No. RR- 289791, for reclaimed water retrofitting.

BE IT FURTHER RESOLVED, that the City Auditor is authorized to expend an amount not to exceed \$93,000 from Water Revenue Fund 41500, CIP No. 70-941.0, Annual Allocation for Reclaimed Water Retrofit Systems, of which \$78,000 is to fund the Reimbursement Agreement and \$15,000 is to fund required work by City Forces.
