RESOLUTION ADOPTING THE REVISED
CONFLICT OF INTEREST CODE FOR THE
SAN DIEGO POLICE DEPARTMENT

WHEREAS, by Resolution R-285031, adopted on December 5, 1994, the City Council approved the San Diego Police Department's (Police Department) Conflict of Interest Code, which was revised and updated following the required City-wide biennial review conducted in 1994 of all conflict of interest codes for which the City Council serves as code reviewing body; and

WHEREAS, during the 1996 biennial review no changes to the Police Department's Conflict of Interest Code were identified as necessary; and

WHEREAS, Government Code section 87306 requires agencies to amend their conflict of interest codes whenever an amendment is necessitated by changed circumstances, including the creation of new positions which must be designated and relevant changes in the duties assigned to existing positions; and

WHEREAS, the Police Department has proposed changes to Appendix A of that department's conflict of interest code to accurately reflect designated positions and appropriate disclosure categories that have been identified since the 1996 biennial review was conducted; and

WHEREAS, the Fair Political Practices Commission (FPPC) has adopted a regulation (located at 2 California Code of Regulations section 18730), which contains the terms of a standard conflict of interest code; and

WHEREAS, after public notice and hearing this regulation may be amended by the FPPC

to conform to amendments in the Political Reform Act; and

WHEREAS, as The City of San Diego's code reviewing body, the City Council finds it in the public interest to adopt the standard conflict of interest code promulgated by the FPPC in Regulation 18730 and hereby declares its intention to incorporate by reference the terms of FPPC Regulation 18730 and any amendments to the regulation duly adopted by the FPPC as part of the Police Department's Conflict of Interest Code; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Police Department's proposed changes to Appendix A of the office's conflict of interest code are hereby approved and are incorporated into its conflict of interest code;

BE IT FURTHER RESOLVED, that revised Appendix A to the Police Department's Conflict of Interest Code be placed on file in the Office of the City Clerk as Document No. RR-289837.

BE IT FURTHER RESOLVED, that the terms of 2 California Code of Regulations section 18730 and any amendments to that regulation duly adopted by the FPPC are hereby adopted and incorporated by reference in the Conflict of Interest Code for the Police Department;

BE IT FURTHER RESOLVED, that a copy of 2 California Code of Regulations section 18730 and any amendments to that regulation be placed on file with the City Clerk as Document No. RR-287942-1

BE IT FURTHER RESOLVED, that Appendix B to the Police Department's Conflict of Interest Code as adopted by Resolution R-285031 on December 5, 1994, remains in full force and continues to be incorporated into the Police Department's Conflict of Interest Code;

BE IT FURTHER RESOLVED, that the revised Conflict of Interest Code for the Police Department, including revised Appendix A and existing Appendix B, becomes effective upon the

date of adoption of this resolution.
