RESOLUTION NUMBER R- 289859 ADOPTED ON MAR 1 7 1998

RESOLUTION PURSUANT TO SECTION 147(f) OF THE INTERNAL REVENUE CODE OF 1986 APPROVING THE ISSUANCE OF BONDS BY THE HOUSING AUTHORITY OF THE CITY OF SAN DIEGO FOR BRIDGEPORT PROPERTIES.

WHEREAS, on MAR 1 7 1998 , the Housing Authority of The City of San Diego (the "Authority") adopted a resolution that constituted a declaration of official intent to issue not to exceed \$20,000,000 aggregate principal amount of the multifamily housing revenue bonds (the "Bonds") to finance the acquisition and rehabilitation of 461-unit multifamily housing projects known as Bridgeport Properties located at fifty-three scattered sites in The City of San Diego and identified in said resolution (the "Project"); and

WHEREAS, in order for interest on the Bonds for the Project to be tax-exempt, Section 147(f) of the Internal Revenue Code of 1986 requires that the Bonds for the Project be approved by the City Council as the applicable elected representative after a public hearing following reasonable public notice; and

WHEREAS, notice of public hearing with respect to the proposed issuance of the Bonds was published in a newspaper of general circulation in the City on MAR 0.3 1998, and

WHEREAS, the hearing was held on this day and an opportunity was provided for interested persons to express their views on the issuance of the Bonds and on the nature and location of the Project; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of The City of San Diego, as follows:

- 1. This City Council, as the applicable elected representative under Section 147(f) of the Code, approves the issuance of the Bonds for the Project by the Authority, subject to proper authorization of such issuance by the Authority at a future date.
 - 2. This resolution shall take effect immediately upon its passage and adoption.
