RESOLUTION NUMBER R- 289872

ADOPTED ON MAR 24 1998

APPROVING MAP OF CITY OF SAN DIEGO TRACT NO. 94-0646.

BE IT RESOLVED, by the Council of The City of San Diego, that the Council finds that certain map surveyed by Victor Rodriguez-Fernandez, Licensed Land Surveyor, titled "City of San Diego Tract No. 94-0646" (the "MAP"), being a subdivision of Lots 1 and 2 of Higgins Subdivision in The City of San Diego, County of San Diego, State of California, according to Map thereof No. 4299, filed in the office of the County Recorder of San Diego County, August 12, 1959, and Lot A-233 of Addition No. 5 of San Ysidro, in The City of San Diego, County of San Diego, State of California, according to map thereof No. 1405 filed in the office of the Recorder of San Diego County, January 2, 1912, is made in the manner and form prescribed by law and conforms to the surrounding surveys; that the MAP is in substantial conformance with Tentative Map No. 96-0646; that the MAP and the subdivision of land shown thereon is approved and accepted; and the Council accepts on behalf of the public, the following: Corte Amalia, and the street is declared to be a portion of a public street, together with all appurtenances thereto, and dedicated to the public use, as dedicated and shown on the MAP and subject to the conditions set forth on the MAP.

BE IT FURTHER RESOLVED, that the Council finds that street reservation dedicated per Map No. 4299 is no longer needed for the public purpose for which it was granted and is not

shown within this MAP because it is vacated pursuant to City Council Resolution No. R-287284, dated May 7, 1997 and to Section 66499.20 ½ of the State Subdivision Map Act.

BE IT FURTHER RESOLVED, that the Council accepts on behalf of The City of San Diego, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on the MAP and subject to the conditions set forth on the MAP.

BE IT FURTHER RESOLVED, that the City Clerk is authorized and directed to endorse upon the MAP, as and for the act of the Council, that the Council has approved the MAP and that the street is accepted on behalf of the public as stated in this resolution.

BE IT FURTHER RESOLVED, that the City Clerk is directed to transmit the MAP to the County Recorder of the County of San Diego, California, for recordation.
