BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the County Department of Animal Control [DAC], for animal control services, for the period of April 1, 1998 through June 30, 1998, under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-289892.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$442,246 from General Fund Citywide Program - Animal Regulation Services, to be adjusted for actual expenditures and revenues after the close of the contract period, is hereby authorized, solely and exclusively for the above agreement.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer \$442,246 from General Fund Unallocated Reserve, Department 605 to General Fund Citywide Program - Animal Regulation Services, Department 601.

BE IT FURTHER RESOLVED, that the City Manager is directed to negotiate and return to the City Council to award a five-year contract for Animal Control Services with the County for the period of FY 1998 through 2003.

BE IT FURTHER RESOLVED, that the City Manager is directed to begin working with the County on a plan to replace the existing Central Shelter.
