BE IT FURTHER RESOLVED, that the Program Supplement No. 11-5004 (097) to Local Agency-State Agreement for Federal Aid Project No. 11-5004 (034), for an amount of \$2,683,293 for Replacement of the Hollister Street (Bailey) Bridge Over the Tijuana River, is hereby authorized solely and exclusively for providing funds for said project and related costs.

BE IT FURTHER RESOLVED, the City Manager is authorized to expend an amount not to exceed \$3,353,293 from CIP 52-625.0, Replacement of the Hollister Street (Bailey) Bridge Over the Tijuana River, of which \$2,683,293 is from Program Supplement No. 11-5004 (097),

Fund 38713, contingent upon receipt of the executed Program Supplement; and an amount not to exceed \$670,000 from TransNet Fund 30300, for the purpose of executing this contract provided that the City Auditor first furnishes a certificate demonstrating that the funds necessary for such expenditures are, or will be, on deposit in the City Treasury.
