BE IT FURTHER RESOLVED, that the Council finds that project revisions now mitigate potentially significant effects on the environment previously identified in the Initial Study and

#### MITIGATION MONITORING AND REPORTING PROGRAM

# Rezone of Parcel D at 8657 Navajo Road DEP No. 96-8542

This Mitigation Monitoring and Reporting Program is designed to ensure compliance with AB 3180 (1989) during implementation of mitigation measures. This program identifies at a minimum: the department responsible for the monitoring, what is to be monitored, how the monitoring shall be accomplished, the monitoring and reporting schedule, and completion requirements. A record of the Mitigation Monitoring and Reporting Program will be maintained at the offices of the Development Services Department, 1222 First Avenue, Fifth Floor, San Diego, CA 92101. All mitigation measures contained in the Mitigated Negative Declaration (DEP No. 96-8542) shall be made conditions of the rezone as may be further described below.

# Parking

Prior to approval of the rezone, the applicant shall execute a parking agreement which permits the subject property to share 34 parking spaces with the adjacent Navajo Center. The purpose of the agreement is to ensure that the subject property would have adequate parking if use of the site were maximized according to the CA zone.

The above mitigation monitoring and reporting program may require additional fees and/or deposits to be collected prior to the issuance of building permits, certificates of occupancy and/or final maps to ensure the successful completion of the monitoring program.
