A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TRANSFERRING \$75,000 FROM THE SUNSET CLIFFS NATURAL PARK TRUST FUND TO SUNSET CLIFFS SHORELINE PARK MASTER PLAN AND AUTHORIZING EXPENDITURE OF THESE FUNDS FOR THE PURPOSE OF COMPLETING THE MASTER PLAN.

WHEREAS, on September 29, 1992, the City Council by Resolution No. R-280748 authorized the City Manager to deposit monthly rents from the Vollmer Life Estate and the Dixon Life Estate on Sunset Cliffs Natural Park into the trust account of Fund No. 63034 to be used exclusively to benefit Sunset Cliffs Natural Park, and

WHEREAS, on July 9, 1996, the City Manager approved the Second Amendment to Agreement, authorizing the consultant to complete the Master Plan and prepare an Environmental Impact Report required for the Master Plan document; and

WHEREAS, additional funds are needed for a Third Amendment to Agreement to provide for additional studies requested by the community as part of the environmental public review process and staff charges necessary for completion and processing of the document for approval; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That \$75,000 from Sunset Cliffs Natural Park Trust Fund No. 63034 be transferred to CIP No. 28-005.0, Sunset Cliffs Shoreline Park Master Plan.

2. That the expenditure of \$75,000 from CIP No. 28.005.0, Sunset Cliffs Shoreline Park Master Plan, is hereby authorized for the purpose of completing the Master Plan, previously approved on September 29, 1992, by Resolution No. R-280748.
