

RESOLUTION NUMBER R- 289992

ADOPTED ON APR 21 1998

WHEREAS, on June 27, 1997, Imperial Industrial Group, Ltd., submitted an application to Development Services for a Conditional Use Permit/Otay Mesa Development Permit for the U.S. Marshal Service Seized Vehicle Storage and Auction Facility; and

WHEREAS, the matter was set for a public hearing to be conducted by the Council of The City of San Diego; and

WHEREAS, the issue was heard by the Council on April 21, 1998; and

WHEREAS, the Council of The City of San Diego considered the issues discussed in Mitigated Negative Declaration No. 96-7579; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it is hereby certified that Mitigated Negative Declaration No. 96-7579, on file in the office of the City Clerk, has been completed in compliance with the California Environmental Quality Act of 1970 (California Public Resources Code section 21000 et seq.), as amended, and the State guidelines thereto (California Code of Regulations section 15000 et seq.), that the declaration reflects the independent judgment of The City of San Diego as Lead Agency and that the information contained in the report, together with any comments received during the public review process, has been reviewed and considered by this Council in connection with the approval of the permit for the U.S. Marshal Service Seized Vehicle Storage and Auction Facility.

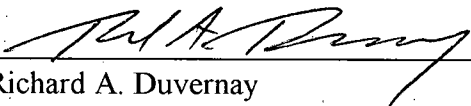
BE IT FURTHER RESOLVED, that the Council finds that project revisions now mitigate potentially significant effects on the environment previously identified in the Initial Study and

EXHIBIT A

MITIGATION, MONITORING AND REPORTING PROGRAM

U.S. MARSHALS SERVICE

CONDITIONAL USE PERMIT/OTAY MESA DEVELOPMENT PERMIT NO. 96-7579

This Mitigation, Monitoring and Reporting Program is designed to ensure compliance with Public Resources Code Section 21081.6 during implementation of mitigation measures. This program identifies at a minimum: the department responsible for the monitoring, what is to be monitored, how the monitoring shall be accomplished, the monitoring and reporting schedule, and completion requirements. A record of the Mitigation, Monitoring and Reporting Program will be maintained at the offices of the Development Services Department, 1222 First Avenue, Fifth Floor, San Diego, CA 92101. All mitigation measures contained in the Mitigated Negative Declaration (LDR No. 96-7579) shall be made conditions of Conditional Use Permit/Otay Mesa Development Permit No. 96-7579 as may be further described below.

Transportation/Circulation

1. Prior to the issuance of any building and/or grading permits, the applicant shall assure by permit and bond, the installation of 100 feet of left turn pocket with appropriate transition for the southbound to eastbound traffic at the intersection of La Media Road and Airway Road, satisfactory to the City Engineer.
2. Prior to the issuance of any building and/or grading permits, the applicant shall assure by permit and bond, the installation of 100 feet of left turn pocket with appropriate transitions on Airway Road at the project driveways, satisfactory to the City Engineer.

The above Mitigation, Monitoring and Reporting Program may require additional fees/deposits to be collected prior to the issuance of grading or building permits to ensure the successful completion of the monitoring program.
