A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN
DIEGO RATIFYING THE ELECTION RESULTS OF
MARCH 18, 1998, FOR THE BARRIO LOGAN
REDEVELOPMENT PROJECT AREA COMMITTEE.

WHEREAS, the Council of The City of San Diego (the "Council") by Resolution No. R-274652, adopted the Procedure of the Formation of a Project Area Committee ("PAC") for the Barrio Logan Redevelopment Project Area Committee at its October 30, 1989, meeting; and

WHEREAS, on May 5, 1997, the Council by Resolution No. R-288626 approved the PAC representatives initially elected to the PAC on March 19, 1997; and

WHEREAS, since the initial March 19, 1997, election of PAC members, vacancies have occurred on the PAC; and

WHEREAS, an election of the PAC was conducted on March 18, 1998, after notice and according to the PAC bylaws and established procedures enumerated within the documents approved by the Council; and

WHEREAS, a representative from the City Clerk's Office attended the election to ensure its validity; and

WHEREAS, the newly elected members of the PAC have submitted to this Council information establishing the qualifications of each person relative to district, category, or organization as appropriate; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

3. That the Redevelopment Agency of The City of San Diego is hereby directed to consult with and obtain the advice of the PAC pursuant to the provisions of the California Community Redevelopment Law (California Health and Safety Code section 33000 et seq.).
