BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$100,000 from DIF Fund #79508 to the Point Loma Library Fund CIP 350670, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$100,000 from DIF Fund 79508, Dept. 30244, Org. 106 Point Loma Library Fund 305670, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
