### EXHIBIT A

#### MITIGATION MONITORING AND REPORTING PROGRAM

#### VISTA LANE REZONE

#### TENTATIVE MAP AND REZONE NO. 96-0480

This Mitigation Monitoring and Reporting Program is designed to ensure compliance with Public Resources Code Section 21081.6 during implementation of mitigation measures. This program identifies at a minimum: the department responsible for the monitoring, what is to be monitored, how the monitoring shall be accomplished, the monitoring and reporting schedule, and completion requirements. A record of the Mitigation Monitoring and Reporting Program will be maintained at the offices of the Development Services Department, 1222 First Avenue, Fifth Floor, San Diego, CA 92101. All mitigation measures contained in the Mitigated Negative Declaration (LDR No. 96-0480) shall be made conditions of Tentative Map No. 96-0480 as may be further described below.

## Noise

- 1. Prior to recordation of the Final Map and/or issuance of a grading permit, the installation of a six-foot high noise barrier, constructed of concrete masonry or brick, along the entire northern boundary of the project site shall be made a condition of the grading permit.
- 2. For residential structures constructed on Tentative Map No. 96-0480 Lot Nos. 4, 5, 6, and 8, mechanical ventilation sufficient to enable the closure of all north- and east-facing windows during hot weather is required. Plans submitted for residential building permits on the above lots shall include an adequate ventilation system.

The above mitigation monitoring and reporting program may require a deposit to be collected prior to recordation of the Final Map to ensure the successful completion of the monitoring program.
