BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized to expend grant funds in the amount of \$35,830 in the execution of said Agreement;

BE IT FURTHER RESOLVED, that Council hereby authorizes the Chief of Police, on behalf of the City Manager, to execute all aspects of this Agreement, including any amendments, extensions or renewals thereof, and to certify that the City will comply with all applicable

statutory or regulatory requirements related to said Agreement;

BE IT FURTHER RESOLVED, that any resources received hereunder shall not be used to supplant expenditures controlled by this body.
