WHEREAS, the City of San Diego Police Department wishes to enter into an Agreement with Natalie Pearl Consulting in the amount of \$35,830 to provide professional services required, and funded, by said grant; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager be and is hereby authorized and empowered, for and on behalf of the City of San Diego, to select Natalie Pearl Consulting on a sole source basis to provide professional services required by said grant;

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized and empowered to enter into an Agreement, a copy of which is on file in the Office of the City Clerk as Document No. RR-290312, with Natalie Pearl Consulting to provide professional services required by said grant;

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized to expend grant funds in the amount of \$35,830 in the execution of said Agreement;

BE IT FURTHER RESOLVED, that Council hereby authorizes the Chief of Police, on behalf of the City Manager, to execute all aspects of this Agreement, including any amendments, extensions or renewals thereof, and to certify that the City will comply with all applicable

statutory or regulatory requirements related to said Agreement;

BE IT FURTHER RESOLVED, that any resources received hereunder shall not be used to supplant expenditures controlled by this body.
