

RESOLUTION NUMBER R- 290421

ADOPTED ON JUN 30 1998

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING SIX NEW FEES AND THREE REVISED FEES FOR INCLUSION IN THE PARK AND RECREATION DEPARTMENT'S FEE SCHEDULE.

WHEREAS, Administrative Regulation 95.25 "Processing New and Revised Fees and Charges for Current Services" requires that departments annually analyze services to determine if new fees are appropriate and if current fees reasonably recover the cost of providing the services; and

WHEREAS, during the annual review of Park and Recreation Department fees, it was determined that six new fees and three revised fees were appropriate to bring the fees in line with and make them comparable to fees of other agencies; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That persons with physical disabilities, subject to proof of disability in the form of a doctor's slip or disabled parking placard, receive a discount equal to that provided seniors, in the fees charged for athletic field reservations, gymnasium reservations, pool admission, water exercise, and building use.
2. That the fees charged for pool guards be increased from \$11.25 to \$12.50 to recover direct costs associated with providing additional pool guards.
3. That a fee of \$1.50 per hour be charged per each participant in the adult masters swim team, such fees to be collected monthly based upon the total hours calculated for the

program.

4. That a fee of \$1.50 per hour be charged for each participant in adult water polo classes, such fees to be collected monthly based upon the total hours calculated for the program.

5. That a fee of \$30.00 per person be charged per each participant in California Emergency Water Safety classes, in order to recover the direct costs associated for providing the class.

6. That a fee of \$92.00 per person be charged per each participant in the Emergency Response classes, in order to recover direct costs associated for providing the class.


7. That a fee of \$29.25 per person be charged per each participant in the First Aid for Public Safety Personnel classes, in order to recover direct costs associated for providing the class.

8. That a fee of \$5.00 per weekday tournament player, and \$10.00 per weekend tournament player be imposed for all golf tournaments at the Torrey Pines Golf Course. This fee shall not apply to Park and Recreation Department sponsored tournaments or the Torrey Pines Men's and Woman's Golf Clubs.

9. That a fee of \$2.00 per weekday and weekend tournament player be imposed for all golf tournaments at the Balboa Park Golf Course. This fee shall not apply to Park and Recreation Department sponsored tournaments or the Balboa Park Men's and Women's Golf Clubs. In fiscal year 2000, this fee shall increase to the same level as the Torrey Pines Golf

Course tournament fee.
