- 1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for the Old Mission Dam Overlook, filed in the office of the City Clerk of The City of San Diego, California, on July 20, 1998, and bearing official Document No. W.O. 294480 be and the same are hereby approved.
- 2. That the Contract Services Division of The City of San Diego be, and is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
- 3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for the Old Mission Dam Overlook.
- 4. That the FY 98 CIP Budget is hereby amended to reflect the increase of \$163,500.00 in CIP No. 29-448.0.
- 5. That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$163,500 from Mission Trails Antenna Fund, Fund No. 10580 to CIP

 No. 29-448.0, Old Mission Dam Overlook.
- 6. That the expenditure, of an amount not to exceed \$163,500 from CIP No. 29-448.0, Old Mission Dam Overlook, is hereby authorized solely and exclusively for the purpose of providing funds for said project and related costs, and authorizing the Auditor and Comptroller.
