

RESOLUTION NUMBER R- 290454

ADOPTED ON JUL 20 1998

A RESOLUTION DECLARING THE RESULTS OF THE MUNICIPAL PRIMARY ELECTION AND THE SPECIAL MUNICIPAL ELECTION HELD IN THE CITY OF SAN DIEGO ON JUNE 2, 1998.

WHEREAS, a municipal primary election was held in the City of San Diego on Tuesday, June 2, 1998, pursuant to the provisions of Ordinance No. O-18469 (New Series), for the purpose of nominating candidates and, if any candidate received a majority of all votes cast, for the purpose of electing that candidate; and

WHEREAS, a special municipal election was held in the City of San Diego on the same date, pursuant to the provisions of Ordinance No. O-18470 (New Series) adopted March 2, 1998, which special election was consolidated with the state primary election for the purpose of submitting to the qualified voters of the City of San Diego one proposition, Proposition A, to approve or not approve a financing plan for expansion of the San Diego Convention Center, as follows:

WHEREAS, a copy of the certificate of the Registrar of Voters of San Diego County canvassing the returns of the municipal primary election and the special municipal election, as

certified to the City Clerk, has been duly received; and

WHEREAS, a canvass of these elections has been completed and the City Clerk has certified the results to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council finds and determines, pursuant to the provisions of Section 27.2206 of the San Diego Municipal Code, as follows:

I

The whole number of votes cast in the City was 222,068.

II

The total vote received by each municipal candidate at the municipal primary election is as follows:

A. FOR COUNCIL DISTRICT NO. 2 (four-year term)

BYRON WEAR having received a majority of all votes cast is hereby declared elected to the office of Councilmember, District No. 2.

B. FOR COUNCIL DISTRICT NO. 4 (four-year term)

GEORGE STEVENS having received a majority of all votes cast is hereby declared elected to the office of Councilmember, District No. 4.

C. FOR COUNCIL DISTRICT NO. 6 (four-year term)

JAMES HART	2,471

VALERIE STALLINGS having received a majority of all votes cast is hereby declared elected to the office of Councilmember, District No. 6.

D. FOR COUNCIL DISTRICT NO. 8 (four-year term)

DAVID GOMEZ	2,660

JUAN VARGAS having received a majority of all votes cast is hereby declared elected to the office of Councilmember, District No. 8.

The number of votes cast in the City for and against Proposition A, and the total number of votes cast upon that proposition, are as follows:

Proposition A received the affirmative vote of a majority of the qualified voters voting on such proposition and is hereby declared to have been approved.


The number of votes cast in each precinct for and against the proposition is recorded in the Election Returns Book, which book is a part of the records of this Council.
