WHEREAS, on June 30, 1997, the Council of The City of San Diego allocated \$145,000 in TransNet funding for the Otay Mesa-Nestor Livable Neighborhood/Economic Need Fund (30304); and

WHEREAS, Council Districts Two and Eight have directed the City Manager to transfer \$145,000 from the TransNet/Otay Mesa-Nestor Livable Neighborhood/Economic Need Fund (30304) into the FY 99 Capital Improvements Program (CIP) for the design and construction Palm Avenue Improvements in Otay Mesa-Nestor; and

WHEREAS, Council District Eight has directed the City Auditor and Comptroller to transfer \$50,000 from the TransNet/Otay Mesa-Nestor Livable Neighborhood/Economic Need Fund (39304) into CIP No. 52-662.0 (Palm Avenue Median Improvements) for the design and installation of median and other roadway improvements on Palm Avenue between I-5 and I-805; and

WHEREAS, Council District Two has directed the City Auditor and Comptroller to transfer \$95,000 from the TransNet/Otay Mesa-Nestor Livable Neighborhood/Economic Need Fund (30304) to CIP No. 39-225.0 (Palm Avenue - I-5 to 13th Street Improvements) for the design and installation of median and other roadway improvements on Palm Avenue west of I-5; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby amends the Fiscal Year 1999 CIP Budget by adding \$145,000 from the TransNet/Otay Mesa-Nestor Livable Neighborhood/Economic Need Fund (30340).

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$50,000 from the TransNet/Otay Mesa-Nestor Livable Neighborhood/Economic Need Fund (30304) to CIP No. 52-662.0, for the design and installation of Palm Avenue Improvements between I-5 and I-805.

BE IT FURTHER RESOLVED that the expenditure of an amount not to exceed \$50,000 from CIP No. 52-662.0 is hereby authorized solely for the purpose of providing funds for the design and installation of Palm Avenue Improvements between I-5 and I-805.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$95,000 from the TransNet/Otay Mesa-Nestor Livable Neighborhood/Economic Need Fund (30304) to CIP No. 39-225.0, for the design and installation of Palm Avenue improvements west of I-5.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$95,000 from CIP No. 39-225.0 is hereby authorized solely for the purpose of providing funds for the design and installation of Palm Avenue improvements west of I-5.
