BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the County Department of Animal Control [DAC], for animal control services, for the period of July 1, 1998 through June 30, 2003, under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 290573.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$2,227,603 from General Fund Citywide Program - Animal Regulation Services, to be adjusted for actual expenditures and revenues after the close of fiscal year 1999 but not to exceed fixed gross costs of \$3,629,839 less actual net revenue (estimated at \$1,402,232), is hereby authorized, solely and exclusively for the above agreement.
