RESOLUTION NUMBER R- 290600

ADOPTED ON AUG 04 1998

WHEREAS, on March 18, 1997, by Resolution No. R-288456, the Council of The City of San Diego amended the Progress Guide and General Plan and repealed the Tijuana River Valley Plan to implement the Multiple Species Conservation Program [MSCP] Plan in order to retain consistency between the plans; and

WHEREAS, on March 18, 1997, by Resolution No. R-288457, the Council certified the Master Environmental Impact Statement/Environmental Impact Report LDR No. 93-0287, SCH No. 93121073, and adopted the Mitigation Monitoring and Reporting Program for the MSCP Plan; and

WHEREAS, The City of San Diego submitted the repeal of the Tijuana River Valley Plan to the California Coastal Commission for certification as a Local Coastal Program Amendment; and

WHEREAS, upon review of the submittal, California Coastal Commission staff recommended retention of a Local Coastal Program Land Use Plan [LCP-LUP] for the Tijuana River Valley and further recommended the consideration of amendments to the Border Highlands LCP-LUP to assure consistency between the plans; and

WHEREAS, the Environmental Impact Statement/Environmental Impact Report LDR No. 93-0287, SCH No. 93121073, did not discuss the need for an amendment to the Border

Highlands LCP-LUP, which was developed as a special study area with specific recommendations regarding the mining and extraction facilities located in the area; and

WHEREAS, the repeal of the Border Highlands LCP-LUP and adoption of the Tijuana River Valley LCP-LUP was heard by the Council of The City of San Diego on July 28, 1998; and


WHEREAS, the Council of the City of San Diego considered the issues discussed in Addendum File No. 98-0683 to Environmental Impact Statement/Environmental Impact Report LDR No. 93-0287, SCH No. 93121073; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it is certified that Addendum No. 98-0683 to Environmental Impact Statement/Environmental Impact Report LDR No. 93-0287, SCH No. 93121073, on file in the office of the City Clerk, has been completed in compliance with the California Environmental Quality Act of 1970 (California Public Resources Code section 21000 et seq.), as amended, and the State guidelines thereto (California Code of Regulations section 15000 et seq.), that the report reflects the independent judgment of The City of San Diego as Lead Agency and that the information contained in said report, together with any comments received during the public review process, has been reviewed and considered by this Council in connection with the approval of Tijuana River Valley Local Coastal Program Land Use Plan.

BE IT FURTHER RESOLVED, that pursuant to California Public Resources Code section 21081.6, the City Council adopts the Mitigation Monitoring and Reporting Program for Addendum No. 98-0683, which incorporates by reference the MMRP for EIS/EIR LDR No. 93-0287, or alterations to implement the changes to the project as required by this body in

order to mitigate or avoid significant effects on the environment, a copy of which is attached hereto and incorporated herein by reference.

MITIGATION MONITORING AND REPORTING PROGRAM

Addendum to Environmental Impact Report

LDR NO. 98-0683

This Mitigation Monitoring and Reporting Program is designed to ensure compliance with Public Resources Code Section 21081.6 during implementation of mitigation measures. This program identifies at a minimum: the department responsible for the monitoring, what is to be monitored, how the monitoring shall be accomplished, the monitoring and reporting schedule, and completion requirements. A record of the Mitigation Monitoring and Reporting Program will be maintained at the offices of the Land Development Review Division, 1222 First Avenue, Fifth Floor, San Diego, CA, 92101. All mitigation measures contained in the Environmental Impact Statement/Environmental Impact Report DEP No. 93-0287 for the Multiple Species Conservation Program Plan shall be made conditions of approval of the Tijuana River Valley Local Coastal Program/Land Use Plan (LDR No. 98-0683).
