BE IT FURTHER RESOLVED, that the Council hereby authorizes the City Manager to execute all aspects of program operation including any amendments, extensions, or renewals for a period of up to five years, provided funding is made available by the U.S. Department of Justice, Office of Community Oriented Policing Services (COPS), and to certify that The City will comply with all applicable statutory or regulatory requirements related to said program;

BE IT FURTHER RESOLVED, that the City Manager be, and is hereby, authorized to

commit the required matching funds in compliance with the requirements of the Local Law Enforcement Block Grant Program;

BE IT FURTHER RESOLVED, that any resources received hereunder shall not be used to supplant expenditures controlled by this body;

BE IT FURTHER RESOLVED, that personnel positions funded under this grant are not subject to local hiring freezes.
