BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to appropriate and expend an amount not to exceed \$712,000 from Konyn Acquisition Fund 10583 for the purpose of the Konyn acquisition, contingent on the receipt of up to \$2,000,000 in funding from the California State Coastal Conservancy.
