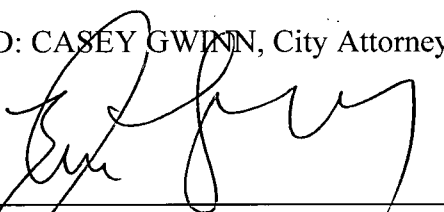
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to execute a FIRST AMENDMENT TO AGREEMENT with GEOLOGIC ASSOCIATES, for as-needed environmental engineering consultant services at the Miramar landfills, and extending the contract for an additional two years, under the terms and conditions contained in the FIRST AMENDMENT TO AGREEMENT, on file in the office of the City Clerk as Document No. RR- 290707.

BE IT FURTHER RESOLVED, that the expenditure of funds not to exceed \$200,000 for professional services for Construction Quality Assurance in construction of the flexible membrane liner from CIP No. 37-056, Construction of West Miramar Landfill Phase II, is hereby authorized.

BE IT FURTHER RESOLVED, that the expenditure of \$210,000 for professional services for water quality monitoring reports is hereby authorized, provided that the City Auditor and Comptroller first furnishes a certificate demonstrating that the funds necessary for such expenditure are, or will be, on deposit with the City Treasury.


